
Safeguarding Adults Level 3 Self-Declaration e-Learning Module

How to complete/renew your mandatory Safeguarding Adults Level 3 Self-Declaration module via ESR e-Learning.

This competency can be signed-off in one of 2 ways; via a classroom training session or via a self-declaration e-Learning module (valid one year). The declaration module should only be completed by staff members that have previously undertaken SAL3 training and are already compliant. The purpose of the module is to confirm (declare) that you are compliant.

It is important to note that the competency that you are looking to sign off is attached to the '*Certification*' on ESR, not to the course. This is important because it is possible to complete the training without achieving the competency if the course is not accessed correctly. You must ensure that you are 'Subscribed' to the correct certification and that you 'Renew' the certification if you are repeating it.

The recommended process for correctly accessing the training is described below:

Log-in to your ESR portal and click the My Compliance & Competency link in the left-hand menu

In the Compliance & Competency screen, look for the NHS/MAND/Safeguarding Adults Level 3 – 3 Years competency, as indicated below

This will take you to the next ESR screen where you will see the Certification Name – Click on the **Details** icon.




Courses

Courses that will give you the competence. Click Details to see classes available for the offering.



The resulting screen will give you the option to Subscribe to the SAL3 Self-declaration certification – please click the Subscribe button.




You will now see a screen that confirms you have 90 days to complete the certification and that it is valid for 365 days. Now click the Finish button.
